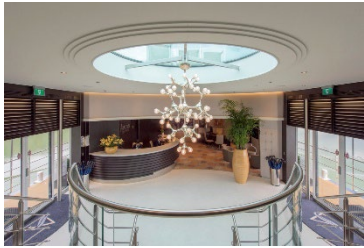
## DAY 1 ~ OVERNIGHT FLIGHT TO PARIS, FRANCE

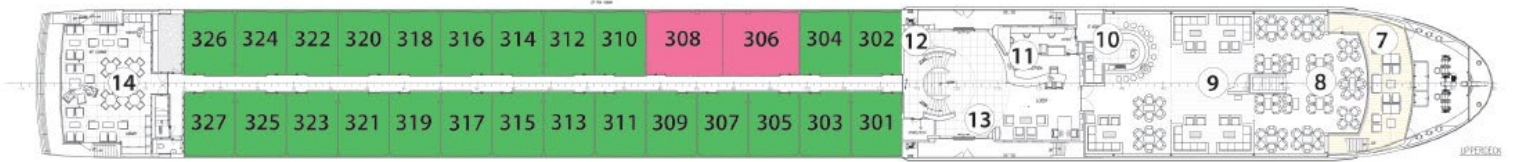

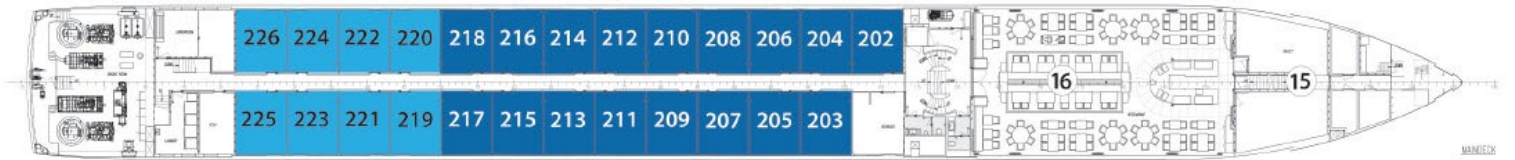

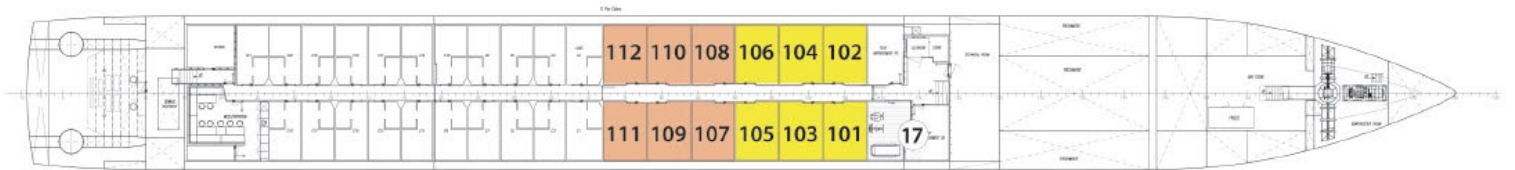
